## **Public Parking Garage Construction**

#### **East Public Garage**

- Elevator installation in progress
- Signage is being installed
- Concrete has been placed on levels 4 and 5 of vehicle ramp
- Entry/exit road has been paved
- Landscape in progress







## Public Parking Garage Ribbon-Cutting

- We will officially open the new public parking garage on Tuesday, August 22<sup>nd</sup> at 4pm with a ribbon-cutting ceremony
- The garage will immediately be available for public parking following the ceremony, adding 1,100 additional parking spaces within easy walking distance to the terminal



## **Employee Parking Garage Construction**








- Concrete placed on level 4, formwork for level 5 is being installed
- Mechanical room is being framed
- Veneer continues to be installed

## **Taxiway W Phase 1**


- Construction on phase 1 started June 12<sup>th</sup> and is expected to take 70 calendar days
- Runway 10L closed due to construction
- FAA fiber optic line has been relocated and is operational
- The base course is being installed this week
- The asphalt test strip was paved on July 26th and has been approved
- Phase 1 construction will be completed prior to the airshow with Phase 2 starting immediately after





### **Taxilane A3 Construction**

- Construction started
   June 26th
- All excavation has been completed
- Base course materials to be placed early August
- Construction work scheduled to be completed before the airshow



### **Taxilane N Construction**

- Construction resumed on June 26th of Taxilane N to tie the new taxilane into Taxiway A and relocate the vehicle service road in this area
- Taxilane is an enabling project for additional corporate hangar construction



## FAA Inspection and Financial Audit

- The Boise Airport recently passed the FAA's annual inspection that ensures we are meeting the requirements of Part 139 Airport Certification
- POWINSTRATION

- Certification inspections include the following steps:
  - Pre-inspection review
  - In-briefing with airport management
  - Administrative inspection of airport files, paperwork
  - Movement area inspection

- Aircraft rescue and fire fighting inspection
- Fueling facilities inspection
- Night inspection
- Post inspection briefing
- BOI is in process with the FAA on a Financial Audit. FAA's onsite visit was completed late July. Audit should be complete in 3-4 months

# Aircraft Rescue and Fire Fighting (ARFF) Status



- Encountered unanticipated maintenance issues on July 11th
  - Typically Index C
  - Reduced to Index B from 4:45PM (Tuesday) to 5:08AM (Wednesday)
  - Resulted in two diversions
  - 128 passengers were displaced (32 per arrival/departure leg)
- Reactive Measures
  - In coordination with the Idaho National Guard an ARFF vehicle was identified and transported from Utah in an expeditious manner
  - The City has executed a lease for a vehicle to allow the necessary time to conduct the required maintenance while maintaining Index which is expected to be delivered in the next 30 days.



## **ACI-NA 2022 Traffic Report**

- Official enplanement numbers for all North American airports (US and Canada) was released by ACI-NA
- Boise Airport came in at #66 for 2022, up from 2021 ranking of #70 and 2019 ranking of #76
- Illustrates our exponential growth in passenger traffic and quick rebound after the pandemic compared to other airports




## **May Enplanements**

*Up 8% from May 2022* 




## June Enplanements


*Up 6% from June 2022*

Up 11% over 2022



factor (83%)




## **Boise Forward Looking Schedule**

Over the next 6 months, BOI's flights are scheduled to be down 3%, while seats are scheduled to remain flat compared to the same months in the prior year


