FAA Reauthorization Bill

Bipartisan bills are currently making their way through both the House and Senate to finalize legislation and funding of FAA programs for the next five years. Airport priorities for further refinement on final bill:

AIRPORT INFRASTRUCTURE FUNDING

Increase Funding and Reform the Airport Improvement Program

- Both House and Senate bills reflect an increase in funding for the traditional AIP to \$4 billion annually as well as extending eligibility to include more capital projects (specifics vary between bills)
- House bill also includes \$100 million annually for supplemental discretionary grants

Modernize the Passenger Facility Charge Program

 Airports support much-need reforms to the PFC program, including proposals to reduce outdated regulatory requirements on PFC projects





FAA Reauthorization Bill

ENVIRONMENTAL ISSUES

Help Airports Make Transition to Florine-Free Firefighting Foam

- Support provisions in the Senate bill that would help airports transition to fluorine-free firefighting foam (F3) by creating a new grant program to buy new foam and dispose of old foam
- Require the FAA to regularly update its national transition plan for airports

Expand Programs to Help Airports Reduce Emissions


- Support provisions that help airports address community concerns regarding aircraft noise and emissions, like the Voluntary Low Emissions Program, Zero Emissions Vehicle Infrastructure Pilot Program, and updating noise standards
- Support forward-looking plans to develop electric capability and natural disaster resiliency projects at airports



DHS: Restore Funding For Key Aviation Security Programs in 2025


Critical airport priorities included in the annual Department of Homeland Security (DHS) spending bill:

- Fund TSA LEO Reimbursement Program: Partially reimburse LEOs who respond to possible threats, like firearms or fentanyl, during the checkpoint screening process
- Fund State and Local-Led Airport Canine Teams: Canine teams detect explosives or explosive material at airports as part of its multi-layered security operations nationwide
- Require TSA to Continue Staffing Exit Lanes: Continue to require TSA to staff exit lanes as required by current law and reject any proposal to shift that cost to airports
- **Properly Resource TSA Security Checkpoints:** Hire officers to handle the growth in passenger volumes and for new effective and efficient screening technologies
- Aviation Worker Screening: Direct TSA to rescind the requirement for airports to procure and utilize explosive detection screening equipment to screen aviation workers





Happy 98th Anniversary BOI!



- The first commercial airmail flight in the United States passed through BOI on April 6, 1926, carried by Varney Airlines
- Passenger air service started in Boise in 1930 when Varney Airlines, which would later become United Airlines, began hauling passengers from Boise—four at a time!
- Moved to our current location in 1936 and became part of the City of Boise in 1946



Employee Parking Garage Construction



- The Airport received a Temporary Certificate of Occupancy for the Employee Garage on 03/19/24
- Targeting mid-April for the opening, dependent upon CONRAC utility work
- Landscaping and site work will continue through May 2024

- Foundation preparations continue
- RAC's are now accessing their lot through Luke Street
- Tower Crane Platform

- GMP Package 3 bids are being vetted and finalized by McAlvain and the Airport



Property Update



- As of March 14, the Airport Inn property has been formally evicted by the Ada County Sheriff, with possession now under the airport's control
- The site has been secured with fencing and measures have been taken to address safety concerns, including increased surveillance by the Boise Police Department



RFQ Update: BOI Upgrade Program: Concourse Development and Terminal Improvements

The Airport is currently interviewing four shortlisted firms for architectural, engineering, and construction administration services for:

Concourse A Development

 80,000SF, double loaded pier, approximately 10 gates

2 Concourse B Renovation

 Existing 60,000SF, 13 Aircraft parking positions and 11 passenger boarding bridges

<u>3</u> Terminal Improvements: depending on future needs & funding

- Ticket Counter Expansion: common use
- Security Checkpoint Expansion
- Baggage Handling System expansion and upgrade

Gate 58 Update


- Air Taxi/Backcountry operators have used Gate 58 for their operations. This gate is located in a future construction area for the Concourse A apron

TSA Facebook Kudos



February Enplanements


Enplanements were slightly above 2023 passenger counts
