Boise Airport procedure to become an Authorized Signatory:

 The <u>Authorized Signatory</u> is the designated individual that is authorized to endorse airport ID media for individuals/employees, among other responsibilities. Please submit a signed letter on company letterhead designating the Authorized Signatory with their contact information and signature, why the company needs airport ID media, and the type of media needed. This letter should be addressed to Jordan Bauer, Alternate ASC (Airport Security Coordinator), and may be submitted in person to Boise Airport's Credentialing Office or emailed to <u>ibauer@cityofboise.org</u>.

- 2. Schedule the Initial Authorized Signatory Training with Jordan Bauer, who may be contacted at <u>jbauer@cityofboise.org</u> or 208-972-8462. This training will take approximately one hour.
- 3. Submit an airport ID media application to the Credentialing Office, located on the third floor of the airport the Credentialing Office will also need two forms of ID (usually a driver's license and passport/social security card/original birth certificate.)
 - a. If the Authorized Signatory will <u>NOT</u> be getting a badge, then they will submit the Signatory Application <u>ONLY</u>.
 - b. Please note the Credentialing Office will not accept SIDA or SAAB applications on Saturday or Sunday.

- 4. Payment is due at the time of service. We accept cash, check, and credit card (Visa, MasterCard, Discover, American Express). For your convenience, advance payment over the phone is accepted by calling 208-972-8415. A table of the applicable fees is below:

5. The application usually takes two to three business days to process. When this has been completed, the Authorized Signatory may complete the computer based training and receive their Airport ID badge.

**The Authorized Signatory must complete the entire badging process before they may endorse airport ID applications for individuals/employees. **
