July Runway Closures

- July 16: 10L/28R, 8:30 p.m. 10:30 p.m. Pavement repairs following lightning strike
- July 17: 10L/28R, 9:30 a.m. 10:30 a.m. Additional pavement repairs following lightning strike
- July 22-26: 10R/28L, 10:00 p.m. midnight Closed for maintenance (cleaning, painting, etc.)
- July 31: 10R/28L, 7:30 a.m. 3:00 p.m. Closed for maintenance (painting)





Runway 10L/28R Closure

- Six week closure to begin after Labor Day
- Reconstruct Taxiway M
- Taxiway F rehabilitation
- Install edge lights and relocate VSR on Taxiway J
- Shift RWY 10L threshold lights inboard





General Aviation Barbecue

- Approximately 20 people attended
- Airport, FAA and TSA briefings
- Master plan airfield overview
- Discussed GA rebadge





Firearm Signage

- TSA and Boise Airport strategic initiative
- Record number of firearms were found in carry on luggage in 2017
- Signage is strategically placed to make people think twice about what they packed





Liquid Dump Station

- Located prior to the security checkpoint
- Encourages reuse of water bottles
- Two dump stations were created so one can be deployed while other is cleaned





Change at the Checkpoint

- Three change collection stations are within the checkpoint
- Allows passengers to donate spare change to three local non profits
 - Neighbors in Need
 - Friends of the Boise Public Library
 - Friends of Zoo Boise



A.C.E. Academy Tours

- The airport hosted two A.C.E. Academy groups from Idaho and Oregon in June
- A.C.E. Academy educates younger generations about careers in aviation




Up 11% May 2018 over May 2017





June Enplanements


Up 10% June 2018 over June 2017
